Product description: UFO MP-1766 Coin, with the face value of 1766 CFA francs, weight 217.70 g (7 oz) and diameter 60 mm, and a set for the Coin display.



The set includes:

- · UFO-1766 Coin,
- · Certificate dedicated to the Coin,
- Printed manual Polish (original) and English (translated from Polish),
- · Charger, adapter (adapter is provided for the Products dedicated to the American market),
- Case basis with a charger slot, lid with two clips on the sides,
- · Cardboard black box.

Each of the parts described above – each one piece per set, presentation of the Product set is provided on the following page number 16.

Each Product set includes:

- 1. Manual
- 2. Collectors coin UFO-1766 Coin
- 3. Certificate
- Charger (with adapter/adapter, depending on the market where the Product will be sold)

- 5. Coin presentation stand
- 6. The lid which is connected to the base by two clips, placed on the sides, connecting the base with the lid
- 7. Cardboard black box



Glossary of the terms used in the document:

- 1. Consumer/Client/User means a natural person who is a buying the Product within the meaning given by the provisions of the Polish Civil Code, or a natural person conducting business activity, for whom the agreement is not of a professional nature, and to whom the Polish Civil Code provides for the application of consumer regulations including rights and obligations of the Manufacturer.
- 2. Distributor an entity to which the Manufacturer has made the Product available for sale, on the basis of the agreement signed with the Manufacturer, distributors is the entity able to prove that he purchased the Product from a legal source.


When the purchase was made abroad from an authorized Distributor, Client should contact Distributor who will support the Client regarding the case of any questions or doubts regarding the use and maintenance of the Product.

- 2. Please refer to the Video Manual presented above before using the Product. On the following pages of the Manual they are the assumptions for the correct disassembly of the Product's set and use of the Product, which in the opinion of the Manufacture's do not cause any additional risks for the User, related to the use of the Product.
- 3. The Manual was originally created in Polish and then translated into English, if it is not possible for the Client to understand or Client doesn't know Polish or English, the Manufacturer will provide the Customer with a translated Users' Manual into the native language of the Client, Distributor of the Product is obliged to provide the Client with all information in the native language of the Client before purchasing the Product.


II. Guidelines of the Manufacturer to use the Product in accordance with the purpose intended by the Manufacturer

1) Preparation and setting up the Product for presentation

 Remove the case in which the Product is placed from the package, release the two clips on the sides, lift the lid, remove the foam protection that holds the Product/charger with the charging adapter (for the Product heading the US market), remove the certificate).



- Sit comfortably at a stable table and place the magnetic base lid on the table.
- Before connecting the cable, check that the socket is ready for use in a safe manner (it is not disturbed, the socket housing to which the socket will be connected is properly placed and the socket in the base of the Product is clean, and there are no foreign objects (dirt/flecks/dust) inside it.
- Connect the base to the power supply via the cable and power charger included within the Product set.



2) Finding the balance point for the Product


• Grasp the Product with two hands and gently lower it over the lid at a height of about 5–15 mm.



 Adjust the position of the Product so that it is centered over the magnet in the lid (placed centrally above the lid, as presented on the illustration provided above), Product should be placed in a stationary and stable manner, when finding the balance point and using the Product. Warning! The Manufacturer does not recommend and stipulates that any possible setting of the Product with the rim or obverse upwards (the side of the coin on which the denomination and the name of the Manufacturer and issuer is located), any attempts to set the coin in motion, in particular around its axis, weighing down the Product, placing on the lid any objects which were not included in the Products' set (another coin, other coins or objects) may cause the Product to fall and damage the lid.

Fall of the Coin may cause damage to nearby property, as well as can cause harm to the people and animals in the vicinity of the Product.

Failure to comply with the above reservations made by the Manufacturer are made at the Clients' own risk, in the event of mechanical damage caused by improper use of the Product, the Manufacturer is not responsible, and has the right to refuse to accept complaints made by the Client.




- When the lid holds the Product, the Product floats above the lid. Leave the Product centrally above the lid.
- Manufacturer reserves that any placement of the Clients' hands under the Product
 while levitating over the lid may be associated with the risk of injury the Product
 may fall on the fingers of the Client. Placing other object or fingers between the lid
 and the Coin may knock the Product out of the field or interfere with the perception
 of the electromagnetic field of the magnets placed in the Products lid, which may
 cause the coin to fall and pose a threat to the User's health or property/ belongings.

3) Product levitation over the lid

- Manufacturer provided the lid only for the Coin UFO MP-1766, attached to the Products' set. Manufacturer envisages the use of the lid for this Coin only.
- In the terms of the Product presentation follow the assumptions indicated in point 2 above (Finding the balance point for the Product).
- If the User observes problems with holding the Coin above the lid or in connection with turning on/off the base of the Coin, take the Coin from above the lid in accordance with the rules set out in point 4 below (Moving the Products' set and turning off the Products' set): pull out the recharge cable, wait 30 seconds, and reconnect it

4) Moving the Product and turning off the Product

- Before disconnecting the Products' lid remove the Coin from above the lid and place it in a safe place or in a Products' case.
- Unplug the lid from the power source and hold the base from underneath using both hands and place it on a hard, flat surface with good adhesion. When putting the lid down, check that children are not around and place the base in an area where children cannot access.
- A possible fall of the Coin on the lid can cause damage and malfunction of the base.
- When turning off the set, the Manufacturer recommends closing the base with the lid in the case provided within the Products' set.



III. Products' safety

- 1. The Manufacturer stipulates that due to the fact that the Products' set includes magnets that emit an electromagnetic field the repulsion force of the magnets has been defined as the force appropriate for repelling objects weighing up to 350 grams, the Manufacturer indicates that as a result of the tests carried out, Manufacturer has not identified any particular threats to human life or health, apart from the usual effects related to the presence of an electromagnetic field associated with the use of the Product.
- 2. No specialized tests related to the impact of the Products' activity on human and animal life or health have been carried out.
- 3. The Manufacturer indicates that it is unavoidable that the usual effects of the environment on the operation of the Product cannot be avoided, including:
 - 1) Power fluctuations and power outages are external factors for which the Manufacturer is not responsible, however, the Manufacturer stipulates that for the correct presentation of the Coin and the functioning of the lid, it is required to provide constant access to electricity. Power outages may cause the Coin to fall on the lid, and the Manufacturer indicates that valuables should not be placed on or near the lid.
 - 2) In the absence of adults, leaving the Coin overnight, leaving the Coin without adult supervision, the Manufacturer recommends turning off the set (in accordance with II, point 4 entitled Moving the Product and turning off the Product).
 - 3) Since the lid is powered by direct current power source if the lid becomes very hot, unplug it and wait at least 10 minutes before trying to connect the lid to the power source again.

IV. Restrictions regarding the Use of the Product

- 1. Products' lid can be installed only on flat surfaces.
- 2. Keep the Product away from metal objects and other electronic devices.
- 3. People with pacemakers should not come into any contact with the Product for their own safety.
- 4. The Product is intended for internal use only and is not a toy.
- 5. The Products' set is a collector's product and is not intended for children, and due to its construction and weight of the Coin, the Products' set should be presented only in the presence of adults and not left to be handled by people under 21 years of age.

V. Contraindications regarding the use of the Product

Due to the fact that the Product uses the magnetic field generated by magnets (1 magnet in the Coin, 4 magnets in the lid), the Manufacturer stipulates that the Product should be displayed and used, taking into account the fact that it may cause adverse effects. Adverse reactions may be related to general recommendations to avoid staying with products that generate possible risks associated with negative effects in the case of:

- 1) pregnancy,
- 2) cancer,
- 3) ionizing radiation irradiation (radiotherapy) and radiological examination period (X-ray),
- 4) implanted electronic implants, e.g. pacemaker,
- 5) severe heart and circulatory system diseases,
- 6) obliterative thrombophlebitis,
- 7) tendency to bleed,
- 8) active tuberculosis,
- 9) acute bacterial and viral infections,
- 10) mycosis.

VI. Imdenification - exclusions of the Manufacturer's liability

- Manufacturer is not responsible for the use of the Product in a manner inconsistent with its intended use indicated in the content of the Manual and indicated in the Video Manual, and to the fullest extent permitted by law. Manufacturer is not responsible for the negative consequences of using the Product except for the use of the Product provided by the Manufacturer in the Manual or Video Manual (in the presented document or virtual form recording.
- 2. Manufacturer is not responsible for potential risks and anomalies due to external influences, among others: power fluctuations and power outages that could cause the Coin to fall on the lid.
- 3. In connection with point 2 above, the Manufacturer informs that valuable items should not be placed on or near the Products' lid, in particular Consumers electronics devices, which proper working may be disturbed by the operation of the lid of the Product.
- 4. The Manufacturer shall not be liable to the Users of the Product for any loss, damage, delay or failure to act caused by causes beyond the control of the Manufacturer. To the fullest extent permitted by applicable law, the Manufacturer's liability for any direct, indirect, incidental, special, or consequential damages, including, but not limited to, loss of data, interruption of service, computer failure or pecuniary loss, loss of income or revenue, loss of business, profits, or contracts, loss of anticipated savings, loss of data, loss of goodwill, wasted management or clerical time, and any other loss or damage of any kind arising out of the use or inability to use the Product is excluded.
- 5. Manufacturer point out that, as with making a purchase transaction through any medium or in any environment, Client should use your best judgment and exercise caution where appropriate.

- 6. Manufacturer is not responsible for the User's decisions made on the basis of the provided instructions or independent interpretations of the use of the Product that deviate from the Manufacturer's guidelines.
- 7. The Manufacturer suggests that before each decision to purchase the Product, you should consult your doubts directly with the entity from which you plan to purchase the Product or consult your doubts after the purchase of the Product, and in case of doubts as to the contraindications to the use of the Product, consult a person with specialist knowledge in the field of the Product the Manufacturer, if the purchase was made through the Manufacturer, or the Distributor.
- 8. Manufacturer's liability towards the User, regardless of its legal basis, is limited both within a single claim and for all claims in total to the amount of the price paid for the purchase of the Product. The manufacturer shall be liable to the User only for typical damages foreseeable at the time of conclusion of the purchase agreement and shall not be liable for lost profits to the User.
